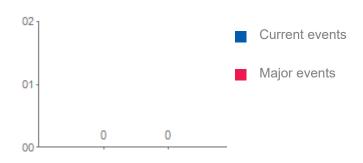

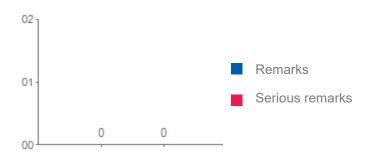

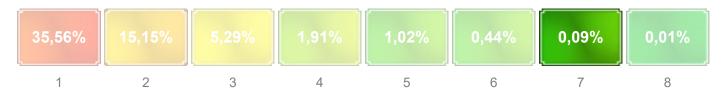


Average industry score

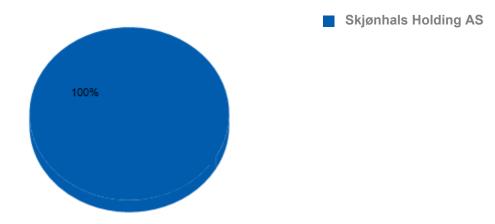

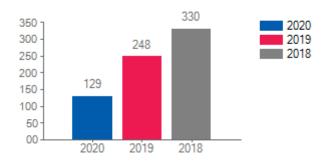

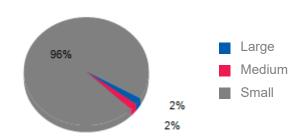

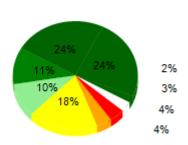
